2. While making any communication with the Board, it is mandatory to mention the Approval Number (Code Number) at the top.
3. The Approval Number (Code Number) of your school/junior college should be written correctly in the application letter of secondary/higher secondary examination. Also, the attested copy of the approval letter given by the Education Department should be attached vide which the Headmaster/Principal has given approval for communication with this office and the approval of the Education Officer/Education Inspector it is mandatory for the recommendation given vide the resolution by the institute to the person, for the post of which the Education Officer (Secondary)/Education Inspector has given approval and the institute has appointed him as the Principal.

4. It will be necessary for it to take the approval as the additional subjects additional medium/stream as per the Rule No. 66 in the Board Regulation in case you wish to teach additional subjects and stream/medium or make any change any it apart from the subjects/stream approved and authorized by this Board vide this approval. In case it is found that the application has been submitted after starting the additional stream/additional medium/subject mutually without the pre-approval of the Board, then kindly note that the application letters submitted to the Board by you will be cancelled unilaterally.

5. The permission of the Government is not required as per the Government letter no. S.S.N./1096/7088/S.E.-1/ Dtd. 03.12.1998 to make any change in the name of your junior college. It will be in the span of authority of the institute to give any name to the junior college. Concerned Education Officer/Education Inspector and Divisional Education Deputy Director should be informed in case of any change is made in the name of the school/junior college in the institute. Also, the change made should be informed to the Board office along with the letter of the resolution of the general meeting of the institute and the letter mentioning the note of the change taken by the Education Officer/Education Inspector, so that the proceeding to change the name will be completed, otherwise it will be not taken in to the consideration.

6. This office should be informed immediately in case your junior college is closed due to any reason.

7. Kindly note that, on the non-fulfillment of the all the conditions or any matters on time for the approval (Code Number) given in the Part - 3 of the Maharashtra Secondary and Higher Secondary Education Boards Regulations, 1977 to your junior college will be cancelled as per the Board Rule No. 69 and you will be responsible for the same.

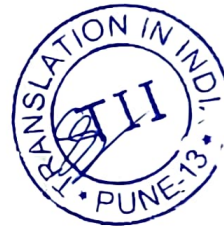
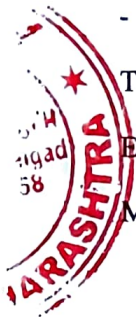
